### Admissions Policy with General Terms and Conditions

#### **Philosophy**

Our Vision at Futuraskolan International School of Stockholm is to *“help our learners to be challenged and grow, to make a positive impact on the world by developing their 8 personal goals,”*

With this vision we want to lift the aspirations and goals of our learners and give them the best start in life. We shall develop each learner’s desire for lifelong learning and help them develop into curious, critical-thinking, resilient, and respectful individuals.

#### **Guidelines and Principles**

At Futuraskolan International School of Stockholm we encourage applicants who are internationally minded, generous in spirit, have the ability to appreciate differences and similarities across cultures and to embrace the diversity among us. We challenge and motivate each learner to reach their full potential and aim to help them develop into caring global citizens.

Both past and present academic performance and behavior in good standing is important.

Requirements for admission include favorable academic standing and respectful interactions among peers and teachers as a member of the international school community.



## **Criteria for Application Form**

If you are applying for a place at Futuraskolan International School of Stockholm it is essential that the learner meets the criteria for applying to an international school.

We will accept learners into our classes based on criteria set by the Stockholm Board of Education (Skolverket) and in the following order:

- o Diplomat
- o Learner(s) in international families moving to Stockholm or the surrounding area and are staying for a limited time period or posting/temporary contract. Attach copy of contract - end date must be provided.  
Note: *Please see below for important information regarding residency status.*
- o Learner(s) of families moving to Stockholm or the surrounding communes/municipalities who have attended an international school abroad for a major part of their education and have a reason to continue their education at an international school.
- o Siblings in Futuraskolan International School of Stockholm
- o Learner(s) permanently living in Stockholm or the surrounding communes/municipalities who will continue their education at an international school abroad in the near future.

Our Admissions Policy is in accordance with Chapter 24 Section 3 of the Swedish Education Act. Within each category, applications will be looked at by Futuraskolan International School of Stockholm using the sibling priority and date of application as some of the key criteria.

## **Application Procedure at Futuraskolan International School of Stockholm**

### **Requested Documents:**

1. A copy of the applicant's passport (if Swedish, copy of Swedish personnummer).  
Note: *If you are a diplomatic family, we also require a copy of your visa and Diplomat ID cards issued by Utrikesdepartementet (State Department).*
2. A copy of the parent/guardian passports, in separate files.  
Note: *If you are a diplomatic family, we also require a copy of your visas.*
3. Documentation of your residency status in Sweden (temporary visa, permanent resident, Swedish citizen, etc)



4. Official school transcripts/report cards (in English) highlighting most recent school years. The official school transcripts/report cards must be combined into one file, e.g. a PDF or a zip file.
5. Psychoeducational reports (applicable for a learner with learning challenges). The psychoeducational reports must be combined into one file, e.g. a PDF or a zip file.
6. If applicable, provide a copy of the parental work contract in Sweden with the end date provided. (See *Criteria for application above*)
7. Application fee - non-refundable 2000 sek application fee
8. Create a Schoolsoft login and register your child.

### **Notification of Admission**

The Admissions Committee consists of the School Administrator, Principal, Vice Principal along with the Learning Support Coordinator and EAL Coordinator (as needed). While we understand that it is not always possible for overseas families to arrange an admissions meeting at the school, it is always preferable to do so.

The Admissions Committee meets regularly to review all applications. Decisions are communicated to families via email when a space becomes available. Families must respond via email confirming whether or not they want to accept the space at Futuraskolan International School of Stockholm. Failure to respond to the email sent will result in the space being possibly forfeited.

There is no deadline for the submission of applications, but the enrollment period will begin during February. We recommend that you send in your application as early in advance as possible.

In order to provide the best learning experience, follow up can be required if:

- Further information needed to make an accurate assessment of grade readiness
- Further EAL testing required
- Further grade level testing if the applicant has some irregularities in school history/age or concerns regarding applications ability to meet the offered curriculum (*Learning Support Coordinator arranges testing using the Woodcock Johnson, MAP or any other relevant test*)
- Academic success and social and emotional well-being, and in times of disrupted education, we do reserve the right to re-evaluation and access your child's class placement should the need arise
- Further information is needed regarding health or learner's welfare issues. Medical diagnosis is important in our assessment of a learner. (Nurse, Counsellor or Learning Support Coordinator to follow up with parents)



### **Entrance Age Requirements**

Upon application, we use the age guidelines listed in the 'DOB for School Year requirements' to assist in our placement of learners into the appropriate grade levels, [DOB for School Year Requirements](#). Futuraskolan International School of Stockholm has over 350 learners representing over 56 nationalities. Supported by an experienced and qualified faculty from over 21 different countries, the study programs, namely the International Primary School Curriculum (IPC), and the International Middle Years Curriculum (IMYC), allow the school to cater to learners' needs regardless of previous international educational experience.

### **Residency Status**

If you are entering Sweden on a work or temporary visa or resident permit AND your status changes during your time in the country, please notify the school directly. We will account for these permissions and follow up each April to inform curriculum planning for the next academic year.

### **Vaccination Policy**

The law in Sweden states that vaccinations are first and foremost voluntary. Futuraskolan AB, and our school, Futuraskolan International School of Stockholm, works with our school's health care facility: Sollentunahälsan. Sollentunahälsan follows the guidelines from the Swedish Public Health Agency through the Infection Protection Act. The Act states: all children in Sweden should be offered the Swedish vaccination program. Sweden has been following the European vaccination program since 2002. The families and learners who move to Sweden and **are considered for enrollment into our school** are asked to provide medical and health documentation, which includes vaccination records. If there is no vaccination documentation provided, our school informs Sollentunahälsan to contact the potential families of learners to provide information about the Swedish vaccination program and encourage them to participate. If the guardian accepts the vaccination program they are referred to BVC (barnavårdscentralen) by Sollentunahälsan. Sollentunahälsan thereafter follows up with the guardian and notifies the school. If the guardian declines the offered Swedish vaccination program, documentation is placed into the learner's journal by Sollentunahälsan and the school nurse. The guardians will be informed about the risks that can arise if they refuse a vaccine, especially MMR, Measles, Mumps, and Rubella.

### **Applicants with Learning Challenges**

Futuraskolan International School of Stockholm offers enrollment to learners with mild to moderate special needs. Parents/guardians of any applicant having a mild special need (either behavioral, physical or learning) must submit complete reports from his/her teacher and therapist. In the case where a special need has not previously been identified, Futuraskolan International School of Stockholm reserves the right to review the situation in order to assess the appropriateness of the



learner's presence at Futuraskolan International School of Stockholm based on our capacity to address their needs.

Futuraskolan International School of Stockholm does not discriminate against any applicant. However in cases where acceptance to the school would imply significant organizational difficulties or sufficient support cannot be provided, an applicant may be declined.

### **Specific Entrance requirements into the IMYC**

Learners should have an adequate level of English to be able to access the curriculum.

Although not mandatory, it is our recommendation that learners should take an intensive English course prior to starting at Futuraskolan International School of Stockholm if their child has a low level of English language knowledge. This is particularly important in Grade 9 if applying to English Language gymnasium/secondary education.

### **Term and Conditions for Futuraskolan International School Stockholm**

#### **Introduction**

Futuraskolan International School of Stockholm is authorized under the supervision of the Swedish School Inspection and in accordance with the standards set out in the Swedish Education Act of 2010 International Schools.

#### **Acceptance**

Acceptance of a learner is made at the school's discretion, in that the learner(s) have met the requirements for attending an International school.

To be considered for admission, the learner must have an international connection. Permanent Swedish residents must either have lived abroad or have plans to live abroad in the near future to be considered for admission.

### **Annual Tuition Fees and Municipal Subsidies**

#### **Annual Tuition Fees**

Futuraskolan International School of Stockholm charges a set Annual Tuition Fee for learner(s) in Grades 1-5, and a set Annual Tuition Fee for learner(s) in Grades 6-9. Annual tuition fees are in addition to the subsidies granted by the municipalities. There are no reduced fees at Futuraskolan International School of Stockholm.

**Application Fee - 2000 SEK (non-refundable)**

**IPC/Primary Grade 1-5 - 32.500 SEK**

**IMYC/Middle School Grade 6-9 - 37.500 SEK**

### **Payment Plan**

The Annual Tuition Fee is reviewed each year by the Board in the month of December and tuition invoices are sent out in February to all current learners and families. In order to secure enrollment for the start of school the following August, a one time payment of the tuition fee must be paid by March 31. The payment is an agreement and acceptance of enrollment in the next academic year. Siblings attending Futuraskolan International School of Stockholm are eligible for a 2 part tuition payment plan with Part 1 (50%) due March 31 and Part 2 (50%) May 31. Please contact School Leadership for more details.

Non-payment of tuition by the expected dates terminates the agreement of enrollment.

### **Reimbursement Percentages**

- A non-refundable enrollment fee of 5000 sek is included within the tuition fee.
- A refund of 100% of the tuition amount paid (minus the enrollment fee) will be returned if the learner does not commence the first term and withdraws their enrollment before the first day of the school year.
- A refund of 50% of the tuition amount paid (minus the enrollment fee) will be returned to families who withdraw from enrollment from the first day of school to October 31.
- A refund of 25% of the tuition amount paid (minus the enrollment fee) will be returned to families who withdraw from enrollment from November 1 to March 31.
- Refunds will not be issued for un-enrollment after March 31.

Learners starting in the second term of the school year will only be required to pay 70% of the Annual Tuition Fee.

### **Municipal Subsidies**

Swedish municipalities provide all children of compulsory school age (Grade 1-9) with subsidies (skolpeng), provided they are registered with the Swedish taxation authorities as residents of Sweden and have a Swedish identification number (personal number or temporary number). The school is not responsible for this registration with the Tax Office - it is the guardian's responsibility. If the subsidy is not granted to the learner, the guardian will be billed for that amount. This subsidized amount of school money or skolpeng is outside the tuition fee that is charged at Futuraskolan International School of Stockholm.



Futuraskolan International School of Stockholm applies a one-time only Application Fee of SEK 2000 for all new applications. This fee is not refundable.

#### **Before and After School Care (Fritids)**

Futuraskolan International School of Stockholm offers its learners before and after school care, this service must be applied for separately and a fee is charged for this care. The fee varies depending on the learner's residence status. For more details please refer to [Fritids Terms & Conditions](#).

#### **Important information**

All learners, their guardians and staff at Futuraskolan are expected to agree and understand our Vision, our Values and our Promise. These are clearly visible on our Website and in school brochures.

*Futuraskolan International School of Stockholm aims to provide our learners with an international education and does not follow Swedish School curriculum, Lgr22, outside French/Spanish/Swedish language classes.*

*We aim to prepare our graduating learners in Grade 9 for an International education track.*
